Holland is tiny, **yet large** and still AAA (13)

- 7th economy in the world when GDP is divided by inhabitants.
- Nr 1 in the world concerning in- and outgoing investments (IMF 2010, DNB), even before US. Out: \$ 3700 bln, in: \$ 3000 bln.
- Human Development Index (UN 2011), 1. Norway, 2. Australia, 3. Netherlands.
- WHO (2012): Dutch kids are happiest (?), acc. Health Behavior in School-aged Children. Also: Belgium, Finland, Iceland. Not: Rumania.
- EGKS (European Union for Coal and Steel) est. 1951, Benelux, France, Italy,
 W-Germany.
- 1957: founding fathers EU (EEG), same countries.
- 2002: Euro est, biggest political event.
- 1.1.2007, Rumania and Bulgaria, now 27 EU members.
- Lost World Championship Soccer 2010 (from Spain).
- 16 mln. inhabitants.
- BENELUX, established 1944 London.
- 1958: economic Benelux union.
- 2010: Benelux Union, still more cooperation, legal, internal affairs, sustainable development.

- Main trading partners: Belgium, Germany.
- The Hague: 4 international tribunals, Interpol.
- A lot of natural gas in the north.

Holland a tax paradise (for multinationals, Shell, Unilever, Philips, Ahold, etc)?

The Dutch government says **NO**; US says **YES** for 2 days (2011);

- A worldwide tax-treaty network favouring international companies who have a mailbox (office)address in Holland;
- No tax, or limited in producing country, nothing in Holland and then through to third country with low final rate;
- No tax on royalties (U2, Rolling Stones)
- Yearly carrousel of capital (2010) € 123 bln. Tax: approximately € 1 bln. per year;
- Ruling practice with Dutch tax authorities;
- A lot of spin off for (service)workers, lawyers, bankers, travel, hotels, meetings, transport, hub-function.



Some bad news as well:

- Coalition government (CDA, VVD, PVV) fell April 22 2012, new elections Sept 12, 2012;
- Two days later a package deal for sobering government spending was ready. EU deadline 30/4, 3% max deficit rule Brussels was kept.

Main items:

- VAT rate 19% to 21%;
- Pension age goes up in 2013;
- Unemployment allowances paid by employers first 6 months;
- Bank tax doubles, € 300 m to € 600 m;
- No cuts for development aid (€ 750 mln);
- One off extra income tax € 500 mln;
- € 1,6 bln cuts in healthcare;
- Reduction of interest deduction mortgages;
- Alcohol, tobacco, soft drinks are taxed more;
- No increase of court fees, € 240 mln;
- All added up € 14 bln.
